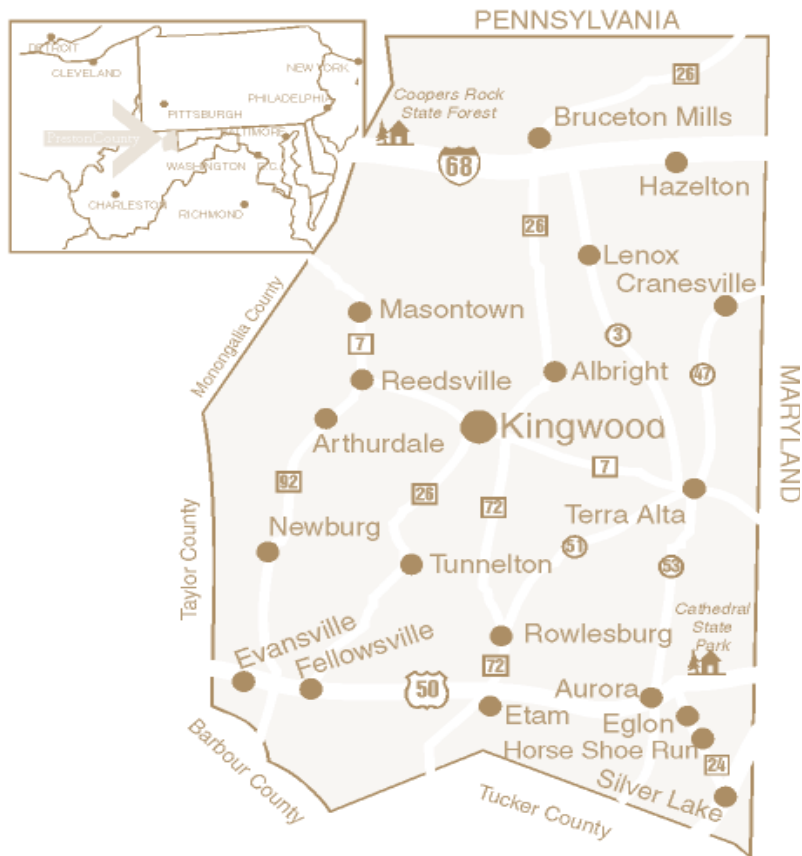

Preston Memorial Hospital, located in Kingwood, is a critical care Hospital licensed for 25 beds (11 acute care, 4 obstetric, and 10 skilled nursing beds) and provides 24-hour emergency care. Additional areas of specialization include cardiac monitoring, nuclear medicine and mammography. Several specialists come to Preston Memorial to see patients during the week. Additional medical facilities are available in Morgantown. Monongalia General Hospital maintains 214 beds and Ruby Memorial Hospital maintains 376 beds. Ruby Memorial has the only Level 1 trauma center in the state.

## BUSINESS ASSISTANCE

The Economic Opportunity Tax Credit is one of West Virginia's best bonuses, and one of the most liberal tax credits available nationally. Through the Economic Opportunity Tax Credit, qualified businesses that create 20 new jobs or more can offset up to 80 percent of its corporate net income, B & O tax, business franchise taxes, and personal income tax (on flow-through business profits only) over a ten year period. This tax credit also contains provisions for corporate headquarters relocation credit and small business credit entitlements. Fewer jobs are required for these credits. Each program's value to a prospective business is calculated as a function of the number of jobs created and the magnitude of the proposed capital investment.

The Manufacturing Investment Credit is made available to manufacturers making qualified capital investments in a West Virginia Industrial facility. The credit is up to 5% of qualified investment over 10 years to offset up to 50% of business franchise tax, severance tax and corporation net income tax. Job creation is not required for this tax credit.

Other tax credits and exemptions include the Strategic Research and Development Tax Credit, the Warehouse "Freeport" Tax Exemption, and Special Property Valuation Statutes.
